NEW MEMBER TRAINING POLICY

Scope

This policy applies to all people who are not members of Cessnock Pistol Club, specifically those who are seeking to train using a handgun without a licence and those who are seeking membership with Cessnock

Purpose

To ensure new members are trained in the safest and most efficient manner while protecting the Club, its trainers and all trainees within the limits of the Firearms Act.

1.0 Club obligations

- 1.1 Cessnock Pistol Club ("Club") will provide safe and appropriate facilities including approved ranges, amenities and firearms for the purposes of training new shooters.
- 1.2 The Club will provide all necessary public indemnity insurance.
- 1.3 The Club will nominate a Training Coordinator ("TC") who will schedule and oversee all training activities of the Club under this Policy. The TC may contact the NSW Firearms Registry to confirm your details.
- 1.4 The Club may at any time reschedule, suspend or cancel a training appointment.

2.0 Trainer obligations

- 2.1 Trainers must be appropriately qualified within the Club's requirements.
- 2.2 Trainers must ensure all legislated requirements are adhered to and all club rules are followed.
- 2.3 Trainers may refuse to train, or terminate a training session for any trainee at any time without the need to provide justification.
- 2.4 Trainers must terminate a training session if there is a serious safety breech by a trainee and that trainee must be interviewed to discuss the incident.
- 2.5 Trainers must only train ONE trainee at any one time.

3.0 Trainee Obligations

- 3.1 All trainees must follow all instructions given by their trainer and must follow all Club rules as provided. Failure to follow instructions will result in exclusion from further training.
- 3.2 All trainees must present themselves on or before their appointed times for a training session. Failure to appear for a training session will result in a disqualification from further training sessions. Contact must be made with the Club 24hrs prior to the training session to reschedule.
- 3.3 All trainees must provide full identification and answer all declarations, forms and questions posed by the Club in a truthful and correct manner. Providing false and misleading information will result in exclusion from further training.
- 3.4 Trainees must inform the Club of a change in details as soon as possible.
